

**DIRECTIONS FOR USE**  
General Classification

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

D102 Detergent Disinfectant has been designed specifically for hospitals, nursing homes, schools, food processing plants and other institutions where housekeeping is of prime importance.

**DISINFECTANT**- To disinfect hard inanimate surfaces (such as walls, floors, table tops), add 2 ounces D102 detergent disinfectant per gallon of water. Apply solution with mop, cloth, or sponge, or mechanical sprayer so as to wet thoroughly. Allow to remain wet for 10 minutes and then let air dry.

To disinfect toilet bowls, flush toilet, add 2 ounces D102 detergent disinfectant directly to the bowl water. Scrub the bowl completely using a scrub brush or toilet mop, making sure to get under the rim. Let stand for 10 minutes and flush.

For heavily soiled areas, a pre-cleaning step is required and recommended. Prepare a fresh solution for each use.

**MILDEWSTAT**- To control mold and mildew on pre-cleaned, hard non-porous surfaces (such as floors, walls, table tops) add 2 ounces D102 per gallon of water. Apply solution with a cloth, mop, or sponge making sure to wet all surfaces completely. Let air dry. Prepare a fresh solution for each use. Repeat application at weekly intervals or when mildew growth reappears.

**SANITIZATION**- To sanitize previously cleaned and rinsed non-porous food contact surfaces, prepare 200ppm active quaternary D102 solution by adding 2 ounces D102 to 1/2 gallons of water.

To sanitize inanimate items (such as tanks, chopping blocks, counter tops), flood the area with 200ppm D102 solution or apply with a cloth or sponge, making sure to wet all surfaces completely for at least 60 seconds. Let air dry. Prepare a fresh solution for each use.

To sanitize drinkable items (such as drinking glasses, eating utensils), immerse in 200ppm D102 solution for at least 60 seconds making sure to immerse completely. Remove and let air dry. Prepare a fresh solution daily or more frequently as need is apparent.

**DANGER**

**STATEMENT OF PRACTICAL TREATMENT**

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash all contaminated clothing before reuse. If swallowed, drink milk, egg whites, gelatin solution or if these are not available drink large quantities of water. Call a physician.

**NOTE TO PHYSICIAN**

Probably minimal damage may contraindicate the use of gastric lavage. Measure against circulatory shock, respiratory depression and convulsion may be needed.

D102 is a phosphate free concentrated detergent disinfectant which provides effective cleaning, deodorizing, disinfection, and sanitization. D102 detergent disinfectant has been designed specifically for hospitals, nursing homes, schools, food processing plants and other institutions where housekeeping is of prime importance in controlling the hazard of cross contamination.

D102 when diluted at the rate of 2 ounces per gallon of water is an effective disinfectant against the organism *Pseudomonas aeruginosa* and meets all requirements for hospital use. When used as directed, D102 is formulated to disinfect inanimate hard surfaces such as walls, floors, sink tops, toilet bowls, tables, chairs, telephones and bed frames. For larger areas such as operating rooms, patient care facilities and restrooms, the product is designed to provide both general cleaning and disinfection.

In addition, D102 deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, toilet bowls and any other areas which are prone to odors caused by microorganisms.

**DISINFECTANT**- At 2 ounces per gallon dilution, D102 exhibits effective disinfectant activity against the following:

At this level the product is also fungicidal against the pathogenic fungi, *Trichophyton mentagrophytes*.

**Virucidal\* Activity:** The product when used on environmental inanimate hard surfaces at 2 ounces per gallon of water exhibits effective virucidal\* activity against Influenza B<sub>2</sub> - (a non-representative of the common flu virus), Herpes simplex (causative agent of fever blisters and mononucleosis), Adeno virus type 2 (causative agent of upper respiratory infections), and Vaccinia virus (representative of the pox virus group).

Efficiency tests have demonstrated that D102 is an effective bactericide, fungicide, and virucide\* in the presence of organic soil (5% blood serum).

**Mold and Mildewstat**- D102 prevents and controls mold and mildew and the odors they cause on hard non-porous inanimate surfaces.

**SANITIZATION**- When used for sanitization of previously cleaned food equipment or food contact items limit active quaternaries to 200ppm. At this level NO POTABLE WATER RINSE is required. D102 is an effective sanitizer when diluted in water up to 250ppm hardness (CaCl<sub>2</sub>).

**STORAGE AND DISPOSAL**
