Pine-Stuff 116 has a fresh, feisty aroma of pine and is an effective disinfecting, deodorizing cleaner. It does the job on any washable hard surface where odor-causing germs flourish. Use it to refreshen the family laundry, deodorize diapers and retard the growth of unsightly, smelly mold and mildew. Without the need for hard rubbing or rinsing, it penetrates grime, grease, wax and films of dirt on floors, walls, tubs, toilets, shower stalls, kitchen sinks and other hard non-food contact surfaces throughout the household.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**ROUTINE CLEANING, DISINFECTING AND DEODORIZING:** To clean, disinfect and deodorize in one application, use 1/2 cup of Pine-Stuff 116 per gallon of warm water. Apply to household surfaces with a cloth, sponge, mop or brush so as to thoroughly wet surface. Let stand for 10 minutes or until air dry. Use on walls, floors, countertops, cabinets, all chrome fixtures, tubs, sinks, shower stalls, hampers and diaper pails. **LAUNDRY:** For added cleaning power and deodorizing family laundry, use 1/2 cup Pine-Stuff 116 with regular soap or detergent per laundry load. **DIAPERS:** As a deodorizer and pre-soak for diapers, rinse gross stools in toilet and soak in bucket containing 1/2 cup Pine-Stuff 116 per gallon of water. **TOILET BOWLS:** To clean, disinfect and deodorizer, pour 1/2 cup Pine-Stuff 116 in clear bowl water. Swab or brush entire inner bowl surfaces. Let stand for 10 minutes. Flush. **EXTRA TOUGH JOBS:** Use Pine-Stuff 116 full strength for stains such as lipstick, scuff marks, tar, gum, oil and grease.
