Without the need for hard rubbing or rinsing, it penetrates grime, grease, wax and films of dirt on floors, walls, tubs, toilets, shower stalls, kitchen sinks and other hard non-food contact surfaces throughout the household.

DIRECTIONS FOR USE

ROUTINE CLEANING, DISINFECTING AND DEODORIZING: To clean, disinfect and deodorize in one application, use 1/2 cup of Pine-Amaze 123 per gallon of warm water. Apply to household surfaces with a cloth, sponge, mop or brush so as to thoroughly wet surface. Let stand for 10 minutes or until air dry. Use on walls, floors, countertops, cabinets, all chrome fixtures, tubs, sinks, shower stalls, hammers and diaper pails. **LAUNDRY:** For added cleaning power and deodorizing family laundry, use 1/2 cup Pine-Amaze 123 with regular soap or detergent per laundry load. **DIAPERS:** As a deodorizer and pre-soak for diapers, rinse gross stools in toilet and soak in bucket containing 1/2 cup Pine-Amaze 123 per gallon of water. **TOILET BOWLS:** To clean, disinfect and deodorizer, pour 1/2 cup Pine-Amaze 123 in clear bowl water.
