

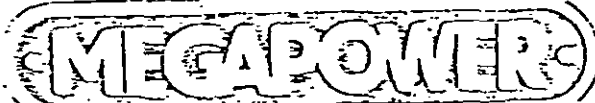
CONTAINER DISPOSAL
