CAUTION: Harmful if swallowed. Avoid breathing vapors. Avoid contact with skin, eyes, or clothing.

FIRST AID: If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution, or, if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Adeptacide-W is used to control bacteria and fungi in recirculating commercial and industrial air wash systems. To its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of 48 fluid ounces of Adeptacide-W of water to provide a concentration of 48 Adeptacide-W in the system, is recommended. Repeat initial Adeptacide-W Subsequent slug additions of 1.53 Adeptacide-W per 100 120 parts per million of Adeptacide-W employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the system. Adeptacide-W is used in air-washing systems that maintain effective concentrations to its use, systems should be cleaned to remove deposits. An initial slug dose of 24.7 Adeptacide-W per 1000 gallons of water should be employed. Repeat initial dosage until control conditions of 16.9 to 41.2 fluid ounces of Adeptacide-W per 1000 gallons of water should be employed. Slug additions may be made to collection trays of the airwash system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not stack more than four drums high. Leakproof drums for disposal. Spills should be absorbed in sawdust or similar material. Container closed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from the use of this pesticide should be disposed of at a government approved waste disposal facility.

CONTAINER DISPOSAL:

- PLASTIC. Triple rinse for equivalent. Then offer for recycling, or, if allowed by state and local authorities, incineration, or, if allowed by state and local authorities, sanitary landfill, by incineration, or, if allowed by state and local authorities, sanitary landfill.
- METAL. Triple rinse for equivalent. Then offer for recycling, or, if allowed by state and local authorities, sanitary landfill, or by other procedures approved by state and local authorities.
