On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

- 1. Submit and/or cite all data required for registration of your product under FIFRA Section 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for re-registration of your product under FIFRA Section 4.
- 2. Before releasing the product for shipment, revise the EPA Registration Number to read, "EPA Reg. No. 48142-7." Submit a final printed label, within 45 days of the date hereon, making the following changes:
  - A. The 'Frost Injury Protection' section, on page 3, may similarly prove more useful and deliberate, if moved under 'General Instructions' section, as were 'Mixing', and 'Chemigation', which altogether offer guidance a user might expect to find under this section.
    - A1. In this section, 'Pseudomonas fluorescens' is misspelled in the second to last sentence.

- B. Under 'Statement of Warranty', revise its sixth sentence so that it reads, "To the extent consistent with applicable law, the exclusive remedy...."
  - B1. Change the tenth line in this section from "Except to the extent prohibited by applicable law, there is no warranty...," to "To the extent consistent with applicable law, there is no warranty...."
- C. In the 'PPE' section, revise its first sentence so that it read, "Mixers, loaders, applicators and other handlers must wear the following."
- D. Additionally, under the 'PPE' include, "Some materials that are chemical-resistant to this product are (registrant is to insert appropriate chemical-resistant material). If you want more options, follow the instructions for category (registrant is to insert A, B, C, D, E, F, G, or H) on an EPA chemical-resistance category selection chart."
- E. Conclude the 'PPE' section, with, "Discard clothing and other absorbent material that have been drenched or heavily contaminated with the product's concentrate. Do not reuse them."
- F. In the 'Agricultural Use Requirements' box, on page 2, revise the current listing of 'coveralls' to 'coveralls over long-sleeved shirt and long pants', which is needed so that early-entry PPE guidance complies with the Copper RED requirements for cuprous oxide products.
  - F1. The following double notification statement must be added to the 'Agricultural Use Requirements' box, "Notify workers of the application by warning them orally and by posting warning signs at entrances to treated areas."
- G. Replace the 'Environmental Hazards' section, as noted in the Copper RED, to read:
  "This pesticide is toxic to fish and aquatic invertebrates and may contaminate water through runoff. This product has potential for runoff for several months or more after application.

  Poorly draining soils and soils with shallow water tables are more prone to product runoff that contains this product. For terrestrial uses, do not apply directly to water, to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment wash-waters or rinsate.

Certain water conditions including low pH ( $\leq$  6.5), low dissolved organic carbon (DOC) levels (3.0 mg/L or lower), and "soft" waters (i.e., alkalinity less than 50 mg/L), increases the potential acute toxicity to non-target organisms.

- I. Either clarify what 'Super Micronized \*' means by using an exclamatory asterisk (\*) or delete the unsubstantiated claim. For example, what is the meaning of 'super'? What does 'micronized' mean? Before using these descriptions in the final printed label, contact us so that we may review your proposal.

J. In the tables on pages 2 and 3, change 'Rate per Acre' to 'Rate per Acre, lbs'.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release of the shipment of your product constitutes acceptance of these conditions.

#### AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling with the Worker Protection Standard, 40 CFR Part 170. The per acre use rates for NORDOX 30/30 WG are applicable for dilute, concentrate and aerial sprays. Where dosage and/or interval ranges are indicated, these may be adjusted according to disease conditions. For example, when conditions favor severe disease pressure, use the maximum rate and shortest spray interval. High rates may be phytotoxic when crop is experiencing environmental stress (hot, dry conditions).

#### MIXING

Add the required amount of NORDOX 30/30 WG to a spray tank partially filled with water and agitate mixture to maintain a uniform suspension. Spreader/stickers, insecticides, nutrients, etc., should be added last. Although this product is compatible with most commonly used agricultural inputs, if compatibility is in question, use the compatibility jar test before mixing a whole tank. Use in accordance with the most restrictive of label precautions and limitations of all products used in mixtures.

Application volumes depend on the crop type, crop size and target pest. Dilute applications are recommended to ensure the best coverage. Adjust the spray volume to obtain maximum coverage without runoff. Concentrate and aerial applications may reduce coverage, thereby reducing effectiveness and also increasing potential for phytotoxicity. Concentrate or aerial applications can provide satisfactory results as long as the spray unit is properly engineered, calibrated and operated.

Do not allow spray to drift from the application site and contact people, structures people occupy at any time and the associated property, parks and recreation areas, nontarget crops, aquatic and wetland areas, woodlands, pastures, rangelands, or animals.

For orchard/vineyard airblast applications, do not direct spray above trees/vines and turn off outward pointing nozzles at row ends and outer rows. Apply only when wind speed is 3-10 mph at the application site as measured by an anemometer outside of the orchard/vineyard on the upwind side.

For aerial applications, the boom width must not exceed 75% of the wingspan or 90% of the rotary blade. Use upwind swath displacement and apply only when wind speed is 3-10 mph as measured by an anemometer. Use medium or coarser spray according to ASAE 572 definition for standard nozzles or VMD for spinning atomizer nozzles. If application includes a no-spray zone, do not release spray at a height greater than 10 feet above the ground or the crop canopy.

The applicator also must use all other measures necessary to control drift. CHEMIGATION: DO NOT apply this product through any type of irrigation system. The following specific instructions are based on general application procedures. Consult with your State Agricultural Experimental Station or State Agricultural Extension Service personnel for additional information as timing, frequency, and number of sprays per season will vary with local conditions.
