Your submission of September 16, 2002

The amendment referred to above, submitted in connection with registration under section (3) of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) is acceptable provided you make the following changes:

**Precautionary Statements:**

- You must add the signal word "DANGER" immediately following the phrase "Hazards to Humans and Domestic Animals". Keep the existing signal word where it is under "Keep out of reach of children."
- In the second sentence of the second paragraph, change "manufactuer's" to "manufacturer's".

**Environmental Hazards:**

Replace the existing text with: "Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NDPES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA."

**Storage and Disposal:**

- Delete the heading "Prohibitions" and add "Do not contaminate water, food, or feed by storage and disposal." directly under the heading Storage and Disposal.
- Change the heading "Storage" to "Pesticide Storage"

Please note that your submission which was identified on EPA Form 8570-1 as a "Final Printed Label" was handled as an amendment. Compliance with PR Notice 98-9 can only be accomplished via notification or amendment. Since a certification statement (refer to PR Notice 98-9) was not included with your submission, your submission was handled as an amendment. In the future, when submitting final printed labels, please note that you cannot make any label changes which have not been accepted by the Agency. Additionally, when submitting future amendments, please use a larger font for your draft labels.

Please submit one copy of your final printed labeling before you release the product for shipment. A stamped copy of the label is enclosed for your records.
