GENERAL CLASSIFICATION

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

IC SANI-CLEAN is a proven "one-step" cleaner-disinfectant-sanitizer-fungicide-mildewstat-virucide in the presence of moderate amounts of organic soil.

Apply IC SANI-CLEAN to walls, floors and other hard (non-porous) surfaces such as tables, chairs, countertops, sinks and bathtubs with a cloth, mop or mechanical spray device so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

Dilution - To deodorize hard, non-porous surfaces treated surfaces must remain wet for 10 minutes.

For hospitals and nursing homes, add 2 oz. per gallon of water. The activity of IC SANI-CLEAN has been evaluated in the presence of 2% serum by the AOAC use dilution test and found to be effective against a broad spectrum of gram negative and gram positive organisms as represented by:

Pseudomonas aeruginosa
Staphylococcus aureus
Staphylococcus chlorureus
Escherichia coli
Bordetella pertussis
Klebsiella pneumoniae
Enterobacter aerogenes
Salmonella choleraesuis
Streptococcus faecalis
Shigella dysenteriae
Brevibacterium ammonoferens

For schools, non-medical institutional and industrial uses: At 1 oz. per gallon of water, IC SANI-CLEAN delivers excellent cleaning and germicidal effectiveness. It is effective against *Staphylococcus aureus*, *Salmonella choleraesuis* and *Escherichia coli*. The same AOAC tests used above to confirm suitable performance for hospitals were used.

Fungicidal Performance -

IC SANI-CLEAN at 1 oz. per gallon is an effective fungicide against *Trichophyton mentagrophytes* (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, dressing rooms, showers and bath areas, exercise facilities, etc.

Mold and Mildew Control

At 1 oz. per gallon, IC SANI-CLEAN will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mildew growth returns.

Virucidal Performance

At 2 oz. per gallon use-level, IC SANI-CLEAN was evaluated in the presence of 2% serum and found to be effective against the following viruses: Influenza A/Brazil, Herpes Simplex and Vaccinia on membrane environmental surfaces.

Sanitizing-Non-Food Contact Surfaces such as floors, walls, tables, etc.: At 1/2 oz. per gallon use-level, IC SANI-CLEAN is an effective sanitizer against *Staphylococcus aureus* and *Klebsiella pneumoniae* in the presence of 2% serum on porous and non-porous environmental surfaces.
