Statement of Practical Treatment

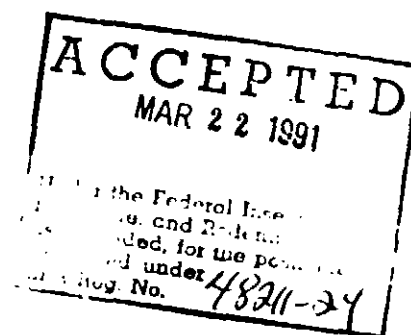

This product is a one-step disinfectant cleaner that is effective against a broad spectrum of bacteria, is virucidal* (including HIV-1), fungicidal, and inhibits the growth of mold and mildew and their odors when used as directed.

This disinfectant is an effective one-step sanitizer-cleaner for use on non-food contact surfaces. When used as directed, this product will deodorize surfaces in toilet areas, behind and under sinks and counters, garbage cans and garbage storage areas, and other places where bacterial growth can cause mal odors.

DANGER

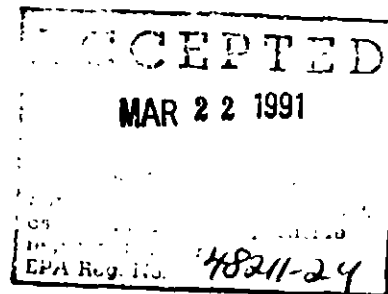
CONTAINER DISPOSAL

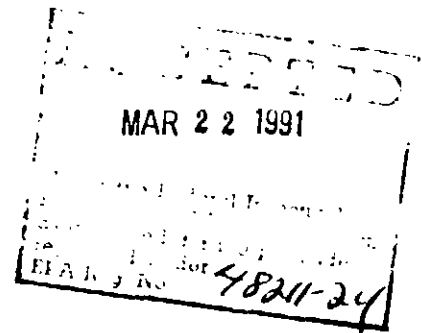
Directions for Use

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. This product is a proven one-step disinfectant-cleaner-sanitizer-fungicide-mildewstat-virucide which is effective in water up to 400 ppm hardness in the presence of 5% serum contamination.

Apply this disinfectant to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, bathtubs, urinals, toilet bowls, fixtures, tile, porcelain, bedframes and hampers with a cloth, mop or mechanical spray device so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

Disinfection - to disinfect hard, non-porous surfaces, add 0.5 oz. per gallon of water. Treated surfaces must remain wet for 10 minutes. The activity of this disinfectant has been evaluated in the presence of 5% serum and 400 ppm hard water by the AOAC use dilution test and found to be effective against a broad spectrum of gram negative and gram positive organisms as represented by:

Staphylococcus aureus

*VIRUCIDAL PERFORMANCE -

At 1/2 oz. per gallon use-level, this disinfectant was evaluated in the presence of 5% serum and 400 ppm hard water for a contact time of 10 minutes at room temperature (20-25 C) against the following viruses found on inanimate hard non-porous environmental surfaces:

HIV-1 (AIDS virus)
Influenza A/Brazil
Herpes Simplex Types 1 and 2
Vaccinia

***KILLS HIV ON PRE-CLEANED ENVIRONMENTAL SURFACES/OBJECTS PREVIOUSLY SOILED WITH BLOOD/BODY FLUIDS in health care settings or other**

PERSONAL PROTECTION: Clean-up should always be done wearing protective latex gloves, gowns, masks and eye protection.

DISPOSAL OF INFECTIOUS MATERIAL: Blood, body fluids, cleaning materials and clothing should be autoclaved and disposed of according to local regulations for infectious waste disposal.

Fungicidal Performance -

This product is an effective fungicide against Trichophyton mentagrophytes (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities at 0.5 oz./gallon.

Mold and Mildew Control. At 0.5 oz./gallon, This disinfectant will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mildew growth returns.

SANITIZING-NON-FOOD CONTACT Surfaces (such as floors, walls, tables, etc.). At 0.5 oz. per 5.5 gallon use-level, this product is an effective sanitizer against Staphylococcus aureus and Klebsiella pneumoniae on hard porous and non-porous environmental surfaces. Treated surfaces must remain wet for 60 seconds.
