DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Remove or cover exposed foods, washed exposed utensils and food preparing surfaces after spraying.

This formulation is to be used undiluted in only such portable thermal applicator equipment that can deliver spray particle sizes within the aerosol size range.

THERMAL APPLICATIONS INDOORS - For the control of flies, mosquitoes and gnats in warehouses, restaurants and industrial institutions. Remove or cover exposed food and food handling surfaces. Remove animals and plant life. Shut off ventilating systems, air ducts, air-conditioning equipment and close off room to be treated. Do not apply while food processing plant is occupied or in operation.

Extinguish all flames and pilot lights. Apply as a dry fog at the rate of 1 1/3 fluid ounces per 1,000 cubic feet of space. Direct nozzle of thermal applicator toward the upper corners of the room and along the ceiling. Close off room for at least one half hour. Do not remain in treated areas. Ventilate the area after treatment.
