- Revise the expression of dosage in footnote 1, listed under the section entitled: "Weeds Controlled", by listing the dosages in a consistent order from low to high.
- 2. Submit one (1) printed copy of the final printed label before releasing the product for shipment under the enclosed stamped label.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA, Section 6(e)... Your release for shipment of the product constitutes acceptance of these conditions.


