- c. On the front panel, after the Statement of Practical Treatment, add the following "child hazard warning" statement: "Keep Out of Reach of Children".
- d. Under the Statement of Practical Treatment, in the "If on skin" statement, add the following sentence: "Get medical attention."
- e. On the front panel add a referral statement indicating where precautionary labeling appears on other than front panel.
- f. Under the section on Personal Protective Equipment, replace the word "coveralls" with the statement, "long-sleeved shirt and long pants".
- g. Under the Environmental Hazards section, in the second sentence, add the following after the last word (water) in the sentence, "...or to areas where surface water is present or to intertidal areas below the mean high water mark."
- h. Under the Storage and Disposal statement, in the Container Disposal section, the second sentence should read as follows: "dispose of empty bag in a sanitary landfill, or by incineration, or, if permited by local and state authorities, by burning."
- 3. Submit one copy of the revised final printed label for the record.

GENERAL INFORMATION

Regal 0-O herbicide is a unique combination of active ingredients for a dry granule application giving the user a broader spectrum of weed control and ornamental plant tolerance. Regal 0-O herbicide is not registered for use on any edible food crops. It has demonstrated effective utility on many ornamental plants as a pre-emergent herbicide, but if its use is not known on any given species - test applications under user conditions are recommended to demonstrate plant safety.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Read entire label before using this product.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. For use on container and field grown ornamentals. Regal O-O herbicide has been thoroughly researched, however, testing has not been conducted on all species or cultivars, or under all growing conditions. In some instances efficacy may vary.

This herbicide is a pre-emergent product, so it should be applied at recommended rate, prior to susceptible weed seed germination, with a suitable spreader which will assure accurate even particle distribution. Do not disturb soil surface once the product has been applied as uniform placement is disrupted and herbicide effectiveness is thereby reduced. Applications should be made to weed free surfaces. Do not apply herbicide granules to wet foliage as phytotoxicity can result. For best results, rainfall or irrigation (approximately 1/2 inch) to water in the herbicide and to wash granules off the plant foliage is recommended.

Apply 2.3 lbs of product per 1000 sq. ft., or 100 lbs/acre, ... For ..., continued weed control, repeat applications are recommended; at: 3-4 month intervals.

Do Not apply over plants that are producing flush new growth. Tender, new leaves are especially sensitive and injury may result.

Do Not use on any varieties or cultivars unless user is familiar with the results on specific plant materials under his growing conditions.
