Application and Your Letter Dated February 9, 2004, Request to Amend Registration by Revising "First Aid Statements" To Comply with EPA PR Notice 2001-1 and

the Precautions and Limitation Section

The proposed amendments to the subject registration reflected on the submitted labeling have been reviewed and found acceptable under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) as amended, provided that you:

- Correct the typographic error by deleting repeat of the heading "Container &/or Field Grown (General)" and the following drawn line in the listing of ornamental for which you claim as use sites.
- 2. Rename the heading of grasses that you claim to be controlled, i.e., the heading "Grassy Weeds" to "Weed Grasses".
- 3. Under "Notice To User" section delete the statement that reads: "Before using O-O Herbicide in tank mixture with other products, test the mixture on a small number of plants for phytotoxicity prior to widespread use." This is a generic claim for use in tank mixtures with other pesticide products. Alternatively, you may add instructions on testing compatibility of potential tank mix partners with this product prior to tank mixing.
- 4. As Regal Crown® does not appear in the text of the proposed labeling, delete the statement that reads: "Regal Crown® is a registered trademark of Regal Chemical Company".

5. Submit one copy of the final printed labeling prior to shipping under the revised labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA, section 6(e). Your release for shipment of this product under the revised labeling constitutes acceptance of these conditions. A stamped copy of the accepted labeling is enclosed for your records.

### **GENERAL INFORMATION**

Regal O-O Herbicide' is a unique combination of active ingredients for a dry granule application giving the user a broader spectrum of weed control and ornamental plant tolerance. Regal O-O Herbicide is not registered for use on any edible tood crops. It has demonstrated effective utility on many ornamental plants as a preemergent herbicide, but if its use is not known on any given species - test applications under user conditions are recommended to demonstrate plant safety

### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Read entire label before using this product.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

### **AGRICULTURAL USE REQUIREMENTS**

Use this product only in accordance with its labeling, and with the Worker Protection Standard. 40 CFR Part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE), and restricted-entry interval. This herbicide is a preemergent product, so it should be applied at recommended rate, prior to susceptible weed seed germination, with a suitable spreader which will assure accirate even particle distribution. Do not disturb soil surface once the product has been applied, as uniform placement is disrupted and herbicide effectiveness is thereby reduced. Applications should be made to weed free surfaces. Do not apply herbicide granules to wet foliage as phytotoxicity can result. For best results, rainfall or imgation (approximately 1/2 inch) to water in the herbicide and to wash granules off the plant foliage is recommended.

Apply 2.3 lbs of product per 1000 sq. ft., or 100 lbs per acre. For continued weed control, repeat applications are recommended at 3-4 month intervals.

Do Not apply over plants that are producing flush new growth. Tender, new leaves are especially sensitive and iniury may result.
