START UP: When starting up a reopened or treshly filled pool or spa make sure the filtration system is clean and operating properly. Then adjust and maintain the pH in the range of 7.4.7.6 using RAM pH MINUS or RAM pH PLUS as indicated by a reliable/test kit. Adjust and maintain total alkalinity 80-125 ppm (spas 140-180 ppm). Next day stabilize between 40-60 ppm using RAM STABILIZER at about 1 lb. per 5.000 gollons (Not required for spas). Bring chlorine reacting up to 3.5 to 5 ppm by superchlorination. Next day apply this concentrate chlorine as directed. Do not use pool (or spa) until the chlorine residual has dropped below 3.0 ppm.

SUPERCHLORINATION: Use 1 lb. SHOCK per 10.000 gations, every 10 to 14 days by broadcasting in pool (Gunite only). DO NOT put into skimmers as other chemicals may be present. This procedure may be necessary more often if algae appears, eye burns, chlorine odors, heavy rains, higher bather loads or hotter pool water are present.

Reentry into treated swimming pool/spas is prohibited above levels of 3 ppm of chlorine.


