The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended is acceptable, provided you make the following changes before you release the product for shipment.

1. The statement "Water Soluble Herbicide Only for Manufacturing, Reformulation, and Repackaging as a herbicide" must be revised to include a complete listing of use sites similar to "...as a herbicide for use in industrial, turf, and ornamental sites, or some or all of the following cropping systems (fill in a list of crops appropriate for your technical).
2. The statement "Reformulation or Repackaging is Prohibited Except In Accordance With An Express Written Agreement with Marman USA, Inc" must be deleted from your label.

Please submit three (3) copies of your final printed labeling incorporating the above changes. Amended labeling will supercede all previously accepted ones. A stamped copy of labeling is enclosed for your records.

Please note for future submissions, labeling requiring revisions will not be stamped "accepted". Labels requiring changes will be rejected pending submission of corrected labeling.
