The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable, provided you make the following changes:

- 1. In the paragraph under Hazards to Humans and Domestic Animals, add "Corrosive." before the statement "Causes irreversible eye damage."
- 2. Under "Specific Requirements for End-Use Product labeling" for "Residential and Turf Uses", revise the personal hygiene statements "for all liquid products" as on the previously accepted label:

"After using this product, rinse gloves before removing, remove clothing and launder separately before reuse, and promptly and thoroughly wash hands and exposed skin with soap and water. Remove saturated clothing as soon as possible and shower."

A stamped copy of the label is enclosed for your records. Submit one copy of your final printed labeling incorporating these changes before you release the product for shipment.
