Hold eyelids open and flush with steady, gentle stream of water for 15 minutes.

Get medical attention.

If Swallowed:

Call a physician or Poison Control Center. Do not induce vomiting. Drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid Alcohol.

5. Add a Note to Physicians to read:

Probable mucosal damage my contraindicate the use of gastric lavage.


6. Submit two copies of the revised final printed label for the record.
