

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

DIRECTIONS FOR SWIMMING POOL CHLORINATION

For a new pool or for spring startup, automatically with a 1 1/2 pint (16 fl. oz.) of sodium hypochlorite solution for each 2500 gallons of water. This dosage is equivalent to 5 ppm available chlorine by weight.

FOR POOL MAINTENANCE:

- 1) Adjust pool water pH to 7.2-7.6 and maintain.
- 2) Add manually or by automatic device; sodium hypochlorite solution at a rate to maintain an available chlorine residual of 0.8 to 1.0 ppm. One half pint (8 fl. oz.) of sodium hypochlorite solution for each 6000 gallons of water will provide 1.0 ppm available chlorine by weight. Frequency of additions is dependent on temperature and of number swimmers. Use test kit to measure the pH and chlorine residual are in the proper range.

NOTE: This product degrades with age. Use a chlorine test kit and increase dosage as necessary, to obtain the required level of available chlorine.

STORAGE AND DISPOSAL: Do Not Contaminate Water, Food or Feed by storage or disposal of cleaning equipment.

STORAGE: Store in a cool, dry area away from direct sunlight.

PESTICIDE DISPOSAL: In case of spill, flood area with large quantities of water. Product or residue that cannot be used, should be diluted with water, and disposed of in a sanitary sewer.

CONTAINER DISPOSAL: Rinse empty container thoroughly with water and either return to manufacturer or discard by placing in trash collection, or burning in an approved land fill.


