

Woodman's 590-10 Clear, 560-10 Semi Transparent, 570-00 Solid Color Stain are oil based stains that offer wide decorative choices as well as outstanding protection. Use on all unprimed woods: siding, roofs, trim, sills, fences, shingles and decorative decks. In traffic areas such as decks, docks, steps and outdoor furniture, a harder finish, PC High Wear Stain will give better wear. PC 590-10 Clear offers protection while maintaining the beauty of the wood as is. PC 560-10 Semi Transparent Stains give the wood color but show wood grain as well as texture. PC 570-00 Solid Color Stains use color to hide the wood grain, but show wood texture. Colors, especially lighter shades vary with all type of wood and the amount of stain applied. With all stains try a small sample to check appearance. Because of deep penetration, stains unlike paint will not crack, blister, or peel. To provide protection, Woodman's Stain contain water repellents and preservatives. In the Northeast, especially, wood is subjected to prolonged exposure to dampness in the early spring and late fall. Unprotected or improperly protected wood picks up moisture and then dries out. After many cycles by itself or combined with ultra violet sun rays, the wood eventually loses its strength. We see degradation as rot, swelling, discoloration, cracking and warping. Therefore careful use and application of Woodman's Stain is a good investment. Read directions carefully. CONTINUALLY STIR CONTENTS.

#### DIRECTIONS FOR USE

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

**PREPARATION:** Before using consider the application of direct sun, rain and low temperatures. Clean area well. Remove all grease. Unless a surface is totally dry, complete absorption and penetration of stain is not possible. Check for stains or water marks that will show through light colors. Test for suspected mildew areas, by applying 50/50 solution of bleach and water to spotted areas. Remove mildew with 1 part bleach and 3 parts water solution. Then follow with clean water rinse. Allow area to dry thoroughly before staining.

**APPLICATION:** Stain is made ready to use. The degree of protection is directly related to the amount of stain absorbed. Avoid lap marks and make it easier to keep a wet open edge by using a good application plan. Second coat may be applied when first is dry to touch. Weathering will generally allow absorption of excess surface stain. Complete drying requires 24 hours. Clean application tools with PC 690-92 Mineral Spirits.

**COVERAGE:** Ranges from 150-300 square ft. depending on wood porosity. Using good painting practices, apply a generous coat by brush, roller, or spray. Initially mix contents thoroughly, and while using STIR CAN REGULARLY TO AVOID SETTLING OF COLOR PIGMENTS.

#### PRECAUTIONARY STATEMENTS

**HAZARDS TO HUMANS AND DOMESTIC ANIMALS: KEEP OUT OF REACH OF CHILDREN.**

**WARNING:** Causes eye damage and skin irritation. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful if swallowed or absorbed through skin. Avoid breathing vapors or mist. This product may cause skin sensitization.

**STATEMENT OF PRACTICAL TREATMENT:** In case of skin contact, wash promptly and thoroughly with soap and water. If product gets in eyes, flush immediately with copious amounts of clean, cool water for 15 to 20 minutes. Get medical attention immediately. If product is swallowed, call a physician or Poison Control Center. Drink a large quantity of milk, egg whites, or gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol.

**NOTE TO PHYSICIAN:** Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression, and convulsion may be needed.

**ENVIRONMENTAL HAZARDS:** This pesticide is toxic to fish. Do not apply directly to water. Permits may be required for discharges containing this pesticide into lakes, streams, ponds, or public water. For guidance, contact the regional office of the Environmental Protection Agency.

**PHYSICAL AND CHEMICAL HAZARDS:** Do not use or store near heat or open flame.

**STORAGE:** Keep container closed when not in use. Store in cool place. Leaking or damaged containers should be placed in a plastic bag and discarded in trash. All pesticides should be kept out of reach of children and stored away from food.

**DISPOSAL:** Do not reuse empty can. Wrap can and place in trash.
