Let stand 10 minutes or until air dry. Prepare fresh solution for each use.

TOILET BOWLS-

Pour 1/3 cup of Pine-Task 204 directly into bowl water. Use brush, mop, or swab to scrub entire inner bowl surface. Let stand 10 minutes for disinfection. Flush.
