Harvest-Pine 209 is a concentrated cleaner disinfectant. It is a multi-purpose cleaner that disinfects and deodorizes as it cleans. Use on floors, walls, tubs, shower stalls, toilets, kitchen sinks, diapers, laundry, and other non-food contact surfaces throughout the house. Wax, crayon marks, and greasy grim or films are easily removed. Use throughout entire bathroom: basin, tub, shower, floor and toilet. Destroys odors instantly. Thoroughly wet all surfaces with Harvest-Pine 209 to insure effective disinfection. Harvest-Pine 209 leaves the breath of fresh forest aroma wherever it is used.

DIRECTIONS FOR USE-

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

CLEANING, DISINFECTING AND DEODORIZING-

Use 1/2 cup of Harvest-Pine 209 to 1 gallon of warm water. Apply with sponge, mop or cloth to floors, walls, cabinets, appliances, countertops, tubs, sinks, shower stalls, garbage pails, chrome fixtures, diaper pails and hamper so as to thoroughly wet all surfaces. Let stand 10 minutes or until air dry. Prepare fresh solution for each use.

TOILET BOWLS-

Pour 1/3 cup of Harvest-Pine 209 directly into bowl water. Use brush, mop, or swab to scrub entire inner bowl surface. Let stand 10 minutes for disinfection. Flush.

FAMILY LAUNDRY/DIAPERS-

For a fresh smelling laundry, add 1/2 cup of Harvest-Pine 209 with regular soap or detergent per laundry load to deodorize towels, blankets, work clothes, and linen to leave family laundry clean and fresh-smelling. To kill odor-causing bacteria in diapers, pre-soak in 1/2 cup of Harvest-Pine 209 per gallon of water.

SPOT AND STAIN REMOVAL AND EXTRA TOUGH JOBS-

Use Harvest-Pine 209 full strength.
