**CLEANING, DISINFECTING AND DEODORIZING-**

Use 1/2 cup of Easy-Pine 218 to 1 gallon of warm water. Apply with sponge, mop or cloth to floors, walls, cabinets, appliances, countertops, tubs, sinks, shower stalls, garbage pails, chrome fixtures, diaper pails and hampers so as to thoroughly wet all surfaces. Let stand 10 minutes or until air dry. Prepare fresh solution for each use.

**TOILET BOWLS-**

Pour 1/3 cup of Easy-Pine 218 directly into bowl water. Use brush, mop, or swab to scrub entire inner bowl surface. Let stand 10 minutes for disinfection. Flush.

**FAMILY LAUNDRY/DIAPERS-**

For a fresh smelling laundry, add 1/2 cup of Easy-Pine 218 regular soap or detergent per laundry load to deodorize towels, blankets, work clothes and linen to leave family laundry clean and fresh-smelling. To kill odor-causing bacteria in diapers, pre-soak in 1/2 cup of Easy-Pine 218 per gallon of water.
