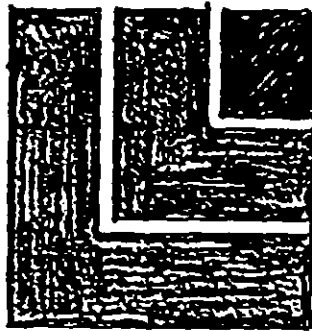

DIRECTIONS FOR USE:

DO NOT USE ON PUPPIES LESS THAN 3 MONTHS OLD. DO NOT USE ON KITTENS LESS THAN 6 MONTHS OLD.

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Keep diluted spray away from light. DO NOT USE MORE THAN 1 OUNCE PER GALLON ON PUPPIES FOR FLEAS AND LICE, dilute Flea & Tick Pet Dip at the rate of 1 ounce (2 Tbs) per 1 gallon of water. For young animals, use 1/2 fl. oz. (1 Tbs) per 1 gallon of water. FOR TICKS, dilute Flea & Tick Pet Dip at the rate of 2 ounces (4 Tbs) per 1 gallon of water. For young animals, use 1 fl. oz. (2 Tbs) per 1 gallon of water. ON CATS, DO NOT USE ON YOUNG KITTENS ON ADULT ANIMALS, DO NOT USE MORE THAN 1 OUNCE PER GALLON. FOR FLEAS, TICKS, AND LICE, dilute Flea & Tick Pet Dip at the rate of 1 ounce (2 Tbs) per 1 gallon of water. Apply directly to animal as a spray, sponge on or a wash. Dip until animal's skin is wet. Do not rinse. Avoid contact with eyes, nose or mouth of animal. To prevent reinfestation, thoroughly spray the animal's living quarters with Flea & Tick Pet Dip, or PPP Flea & Tick Home and Kennel Power Spray.

STORAGE

Store product in original container in a locked storage area.
