Microbiocide () 25 to used in cooling water systems and industrial air washing systems to control microbiolog, all stime. In cooling systems, add 2.3 to 6.8 ft. oz. of Microbiocide D 25 per 1000 gal. of water to the cooling tower sump. In air washing systems, add 8.0 to 13.7 ft. oz. of Microbiocide D 25 per 1000 gal. of water to water collection trays, Repeat treatments every 1.5 days, or as needed. The required frequency depends on relative amount of bleed and severity of slime problem.
