

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

WARNING: Causes eye damage and skin irritation. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed. Avoid contamination of food.

STATEMENT OF PRACTICAL TREATMENT: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. DIRECTIONS FOR USE

It is a violation of Federal law to use this product inconsistent with its labeling.

DS-990 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth and other deposits. An initial slug addition of 6.9 DS-990 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 2.3 DS-990 per 1000 gallons

every 1 to 5 days, or as needed. The frequency of relative amount of bleedoff and the severity of the rust additions should be made in the sump of water cooling

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage. STORAGE: Do not expose to extreme temperatures. Do not store more than five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums. Contents should be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. The excess pesticide, spray mixture, or rinsate is a violation of Federal law. Wastes cannot be disposed of by use according to label directions.
