### PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

#### CAUTION

(18pt)

Do not allow children or pets to contact treated surfaces until coating has dried. May be harmful if swallowed, inhaled or absorbed through skin. Avoid breathing vapors while paint is wet. If swallowed: Drink plenty of water. Call a physician or poison control center.  
If inhaled: As with any freshly painted surface, get plenty of fresh air.  
If in eyes: Flush with plenty of water. If irritation persists, get medical advice.  
If on skin: Wash with plenty of water and soap.

#### ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish, birds and other wildlife. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as recommended on this label.

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Apply SUPER IQ™ APT only on clean and dry surfaces.

MIX WELL BEFORE APPLICATION. Provide adequate ventilation of areas during application and while paint is drying.

Product may be applied with brush, roller or spray. It dries quickly and gives a beautiful finish. It is odorless when dried. Dried coat may be washed with water or water and mild non-alkaline detergents.

Each gallon covers approximately 450 to 500 sq. feet of surface. For best results, use without dilution and apply two coats.

#### STORAGE AND DISPOSAL

Keep container tightly closed and store in a cool, dark place, preferably in a locked storage area.

Product Disposal: Partially filled can may be disposed of by securely wrapping original container in several layers of newspaper and discard in trash.

Container Disposal: Do not reuse empty can. Wrap container and put in trash.
