# GENERAL INFORMATION

Rwc D - 8 G : Semi-Soil Sterilant, when used at rates of 200 lbs. per acre, is an effective general herbicide for the control of most annual and perennial grasses and weeds of non-cropland areas where bare ground is desired.


 $Rw \in D-8G$ . Semi-Soil Sterilant may be used at any time of year for general vegetation control, providing the chemical is moved to the root zone by rainfall or artificial means. Best results are obtained if  $\mathcal{R}w\mathcal{C}$   $\mathcal{D}$ - $\mathcal{B}\mathcal{G}$ . Semi-Soil Sterilant can be applied pre-emergence (before growth starts). The degree of control and duration of effect will vary with the amount of chemical applied, soil type, rainfall and other conditions.

Rwc D-8G Semi-Soil Sterilant is formulated for dry application in power and hand operated spreading equipment. Effects of applications are usually slow to appear and may not become evident until the herbicide has been carried to the root zone by moisture. Because the effectiveness of Rwc D-8G Semi-Soil Sterilant varies with environmental conditions and species of vegetation, users should consult experiment station or extension service weed specialists for suggestions for use under local conditions.
