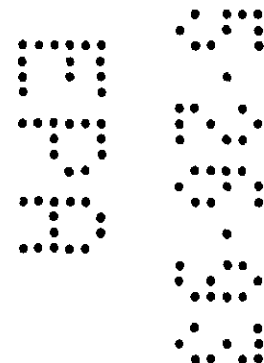

ABOUT SNAILS & SLUGS

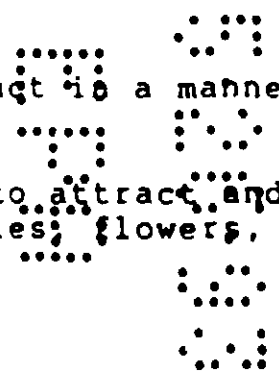
Snails and slugs are mollusks. Slugs are 1-2 inches long and lack the shell found on snails. Snails and slugs feed at night or on overcast, damp days, and prefer succulent plant tissue, especially young seedlings.

Snails and slugs hide in shady areas such as under rocks, boards, ground covers or other low growing plants.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

GRO^R Snail & Slug Bait is specially formulated to attract and kill snails and slugs around many fruits, vegetables, flowers, ornamentals, and ground covers around the home.



GENERAL: For best result apply early evening to damp soil. If needed, water area prior to application. Reapply bait every two weeks as needed, or more often during periods of heavy rain or overhead watering.

Broadcast the bait lightly over the infested area using 1 lb. per 1750 sq.ft.

To prevent snails and slugs from entering gardens from other areas, lightly apply a band 2-3 inches wide around the border of the area to be protected.

Before applying this product, remove debris such as loose board, stones, bricks, or other material where snails and slugs are likely to be found.

FLOWERS, GROUNDCOVERS AND ORNAMENTALS: Lightly broadcast in and around flowers, groundcovers and ornamentals, making sure the bait penetrates dense foliage. Can be used around many Flowers, Groundcovers and Ornamentals including Asters, Azaleas, Camellias, Chrysanthemums, Coleus, Dusty Miller, Geraniums, Gladiolus, Impatiens, Iris, Lily, Myrtle, Petunias, Pachysandra, Rhododendrons, Roses, Stock, Sweet Peas, and Zinnias.

FRUITS AND VEGETABLES: Lightly broadcast around the fruits and vegetables listed below. Do not allow bait to contact edible plant parts. Can be used around many Fruits and Vegetables including Apples, Blackberries, Blueberries, Cherries, Citrus, Grapes, Melons, Peaches, Plums and Strawberries, Asparagus, Beans, Beets, Broccoli, Cabbage, Carrots, Cauliflower, Corn, Cucumbers, Eggplants, Garlic, Lettuce, Onions, Parsnips, Peas, Peppers, Potatoes, Radishes, Rutabagas, Spinach, Squash, Swiss Chard, Tomatoes and Turnips.

STORAGE AND DISPOSAL
