DIRECTIONS FOR USE

It is a violation of Federal law to use this pesticide in a manner inconsistent with its labeling.

Data Chem M-1201 is used to control bacteria, algae, and fungi in recirculating commercial and industrial air-wash systems. Upon its use, systems must be cleaned to remove slime, and other deposits. An initial slug addition of Data Chem M-1201 fluid ounces of Data Chem M-1201 of water to provide a concentration of 32 Data Chem M-1201 per 1000 gallons in the system, is recommended. Repeat initial dose of 1.0 Data Chem M-1201 per 1000 gallons. Subsequent slug additions of 1.0 Data Chem M-1201 per 1000 gallons.

80 parts per million of Data Chem M-1201 should be employed every 2 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the bacterial problem. Slug additions should be made in the circulation of the system. Data Chem M-1201 is used for air-washing systems that maintain effective moisture to its use, systems should be cleaned to remove deposits. An initial slug dose of 14.5 Data Chem M-1201 per 1000 gallons is recommended. Repeat initial dosage until control is achieved. Tons of 10.1 to 24.7 fluid ounces of Data Chem M-1201 per 1000 gallons of water should be employed each week.

STORAGE AND DISPOSAL
