

DIRECTIONS FOR USE

It is a violation of Federal law to use this product inconsistent with its labeling.

Data Chem M-1250 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth, other deposits. An initial slug addition of 5.1 Data Chem M-1250 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 1.7 to Data Chem M-1250 per 1000 gallons every 1 to 5 days, or as needed. The frequency of relative amount of bleedoff and the severity of the problem. Additions should be made in the sump of water cooling system.
