

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Use one (1) tablet per 2 oz. milk sample. Invert sample to mix. Do not overagitate. Tablet should be completely dissolved before testing. Preservo Tablets should be used within one year from date of manufacturing and within three months after opening.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Tablets should be stored in a dry area at temperatures under 80°F. Dessicate after opening. Keep away from: oxidizing materials, metals, sources of ignition, food and food containers, sunlight and fluorescent lights.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then dispose of liner and metal container in a sanitary landfill, or by incineration if allowed by state and local authorities. Dessiccants may be removed and reused according to manufacturer's instructions.
