COOLING TOWERS: WI-340
wood against soft or surface rot and internal or dry rot. It is applied as a solution containing 0.5 to 0.7% by weight WI-340 to wood surfaces. The amount applied should provide 0.6 to 0.8 fl. oz. per 1000 ft.² of wood surface. Soft or surface rot can also be treated with WI-340 to the recirculating cold well. The dosage should provide 1.25 lb. of WI-340 per 1000 gal. of water, and the bleedoff should be stopped for 4 to 6 months should be repeated every four months.

COOLING WATER: WI-340
and fungi in industrial recirculating cooling water systems. Bacteria should be cleaned thoroughly to remove old algal growth, microorganisms. System should then be drained, flushed, refilled with water, and 3.7 fl. oz. of WI-340 per 1000 gal. should be added. Frequent additions of 0.2 to 1.2 fl. oz. per 1000 gal. should be made to control amount of bleedoff and severity of microbiological fouling.

DRILLING FLUIDS: To inhibit bacterial and fungal degradation of wells, WI-340 is added to drilling fluids at concentrations of 0.05 to 0.25% based on the total wet weight of solids.

PETROLEUM SECONDARY RECOVERY: WI-340
control sulfate-reducing bacteria, slime-forming bacteria and micellar floods, water-disposal systems, and other oil-field water systems. 2.0 fl. oz. of WI-340 per 1000 gal. should be made continuously or intermittently by means of knockouts, before or after injection pumps and injection wells. When system is noticeably fouled, add 1.2 to 4.0 fl. oz. WI-340 per 1000 gal. of water continuously until desired degree of control is achieved.

CRUDE AND REFINED OILS: WI-340
inhibitive for the control of bacteria and fungi that cause the degradation of oil during storage. It should be added to the oil as it is being transferred to the storage tank at the rate of 0.6 to 6.0 fl. oz. WI-340 per 1000 gal. of oil. Addition should be made batchwise where multiple transfer side of the transfer pump.

STORAGE & DISPOSAL
