GENERAL CLASSIFICATION

It is a violation of Federal law to use this product inconsistent with its labeling.

Aquari WT-221 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth, other deposits. An initial slug addition of 3.3 Aquari WT-221 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 1.1 to Aquari WT-221 per 1000 gallons of water every 1 to 5 days, or as needed. The frequency of relative amount of bleedoff and the severity of the microorganisms additions should be made in the sump of water cooling system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Do not expose to extreme temperatures. Store in five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and be absorbed in sawdust or sand and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law.
