STORAGE AND DISPOSAL

STORAGE: Keep pesticide in original container. Do not put concentrate or dilute into food or drink containers. Avoid contamination of feed and foodstuffs. Store in a cool, dry place, preferably in a locked storage area. Do not store diluted spray.

DISPOSAL PRODUCTS: Partially-filled can may be disposed of by securely wrapping original container in several layers of newspaper and discard in trash. CONTAINER: Do not re-use empty can. Rinse thoroughly before discarding in trash.

Dormant Oil is a highly paraffinic spray oil. To be used in control of scale, Comstock mealybug, Spruce gall, red spider mites, aphid, larch casebearer, leafroller, for use on apples, peaches, plums, pears, cherries and other deciduous fruit trees, also grapevines and deciduous small fruits, shrubs, shade trees, pines, conifers.

Against San Jose scale, cottony maple scale, European red mite, leafroller, red spider mites, larch casebearer, mealybug. Use Dormant Oil diluted 1 gallon to 50 gallons water, dilute 1 1/2 quarts to 15 gallons water, dilute 5 1/4 tablespoonfuls per gallon of water. Use as a dormant or delayed dormant spray on fruit trees and as a spring dormant spray on deciduous shade trees and ornamentals.

Against oystershell scale, tulip scale, scurfy scale, use 1 1/2 gallons to 50 gallons of water, 2 quarts to 15 gallons of water, 8 to 10 tablespoons per gallon of water. Use as a dormant spray.

On spruces, conifers, pines and evergreens, including broad-leaved evergreens, against spruce gall, scale, red spider mites, use Dormant Oil 3 quarts to 50 gallons of water, 1 quart to 15 gallons of water, 4 tablespoons per gallon of water and apply as a spray just before the new growth starts.

Use when temperature is not colder than 40 °C to minimize the danger of freezing before spray dries on the trees. Thorough spraying of all exposed surfaces is necessary.
