On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

- 1. Submit and/or cite all data required for registration/ reregistration of your product when the Agency requires all registrants of similar products to submit data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
- 2. Make the labeling changes listed below before you release the product for shipment:
 - a. Add the phase "EPA Registration No. 50404-10."
- b. Revise the percent permethrin on the permanent garment label to read exactly as on the removable hand tag; "0.52%".
- c. Delete "spiders" from the product labeling. No data has been submitted to support repellency of this pest.

- 3. You must submit product's storage stability and corrosion characteristics, two product chemistry data requirements of guidelines 830.6317 and 830.6320, respectively. References to source product data will not support the requirements of this 0.52% permethrin as opposed to the source product. The study can be accomplished by storing impregnated garments and testing for any changes in the level of permethrin as well as to the apparels throughout the storage period of a minimum of one year.
- 4. You must submit an enforcement analytical method giving adequate procedure on how to extract permethrin from the apparels and analyze for it. The method must be supported with validation data, sample calculation and chromatograms. References to source product methods will not support the requirements for subject product's 0.52% permethrin in impregnated apparels as opposed to the source product.
- 5. Submit two (2) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
