

BAIRD & McGUIRE'S *Trans from 551-243* ROACH SPRAY

DIRECTIONS FOR USE
ROACH SPRAY is a highly effective formulation which provides rapid kill of crawling insects listed below, including those resistant to certain chlorinated hydrocarbon and phosphate insecticides.

In addition to rapid kill, ROACH SPRAY stays on treated surfaces and kills insects for up to two weeks after the spray deposit has dried.

HOW TO USE: ROACH SPRAY is ready to use undiluted as it comes from the can, and may be applied with either power-operated or hand sprayers. Apply as a course spray to infested surfaces until wet, moving the spray stream rapidly enough to prevent excessive wetting of surfaces and waste of material. Direct spray away from people, plants and pets.

RESTRICTIONS: Do not apply to rugs, carpets, draperies, wallpaper or similar materials that may be stained. Avoid excessive wetting of plastic, rubber asphalt surfaces such as tiles and floor coverings. Do not allow the small, finger-operated, plastic attachment type sprayer to remain in ROACH SPRAY solution for extended periods as the plastic sprayer may be damaged.

OUTDOOR USE:

ANTS, CLOVER MITES, CRICKETS, EARWIGS, FLEAS, MILLIPEDES, SOWBUGS, AND BROWN DOG TICKS: Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios, or other places where insects may enter. For ants, spray hills and runways. Repeat as necessary. Do not spray vegetation.

INDOOR USE:

ANTS, COCKROACHES, CRICKETS, SILVERFISH, SPIDERS, SCORPIONS, WATERBUGS: Spray around baseboards. Apply behind and beneath cabinets, refrigerators, sinks, stove, and in and around waste containers. Repeat as needed. Do not spray foodstuffs or houseplants. For ants, spray trails and places where ants enter premises. Do not allow children to contact treated areas until surfaces are thoroughly dry.

BROWN DOG TICKS: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floors. Repeat as needed. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet areas. Additionally, treat pets with E.P.A. approved product registered for direct application to pets.
