FOOD HANDLING ESTABLISHMENTS – Places other than private residences in which exposed food is held, processed, prepared or served.

FOOD AREAS - APPLICATION LIMITED TO CRACK AND CREVICE TREATMENT ONLY.

Includes areas for receiving, storage, packing (canning, bothing, wrapping, boxing) preparing, edible waste storage and enclosed processing systems imilis, dairies, edible oils, syrups) and serving areas (when food is exposed and facility is in operation).
