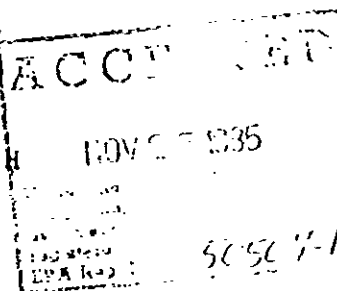

PRECAUTIONARY STATEMENTS

Do not use on Lippia, St. Augustine, Bentgrass, or Dichondra. Do not re-seed for at least two weeks after application. Do not apply to a newly-seeded lawn until after 3 mowings. Do apply when weeds are young and active for best results. Applications when the grass is wet from dew, rain or sprinkling will be more effective. Do not water for at least 24 hours after application. If rain occurs during 24 hours after application, a second application may be necessary.
