DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SYNTRON B-110 is used in recirculating cooling tower systems and industrial and commercial recirculating cooling tower systems. Prior to the use of SYNTRON B-110, the cooling tower should be cleaned to remove algal growth, microbiological slime, and other deposits. An initial slug addition of 12.0 to 17.9 fl. oz. of SYNTRON B-110 per 1000 gal. of water to provide 100 to 150 ppm of SYNTRON B-110, based on total weight of water in the system, until control is evident. Make subsequent slug addition of SYNTRON B-110 per 1000 gal. of water every 2 to 5 days. The amount of addition depends upon the relative amount of bleedoff and microbiological problem. Slug additions should be made to the bleedoff system.

SYNTRON B-110 is used in cooling tower systems which maintain effective mist-eliminating components. Prior to the use of SYNTRON B-110, the cooling tower should be cleaned to remove bacterial slime and other deposits. An initial slug addition of 35.9 fl. oz. of SYNTRON B-110 per 1000 gal. of water is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 21.0 to 35.9 fl. oz. of SYNTRON B-110 per 1000 gal. of water should be employed every 1 to 5 days, or until control is evident. The amount of addition depends upon the relative amount of bleedoff and microbiological problem. Slug additions may be made to the bleedoff system.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Do not expose to extreme temperatures. Do not stack more than 10 drums. Drums should be placed in overpack drums for disposal. Spills should be absorbed and disposed of in a sanitary landfill. Keep container closed when not in use.
