Directions for Use

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

SYNFECT 256 is a proven "one-step" disinfectant-cleaner-sanitizer-fungicide-mildewstat-virucide which is effective in water up to 400 ppm hardness in the presence of 5% serum contamination.

Apply SYNFECT 256 to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bedframes with a cloth, mop or mechanical spray device so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

Disinfection-to disinfect hard, non-porous surfaces, add 0.5 oz. per gallon of water. Treated surfaces must remain wet for 10 minutes. The activity of SYNFECT 256 has been evaluated in the presence of 5% serum and 400 ppm hard water by the AOAC use dilution test and found to be effective against a broad spectrum of gram negative and gram positive organisms as represented by:

Fungicidal Performance-

SYNFECT 256 is an effective fungicide against Trichophyton mentagrophytes (the athlete's foot fungus) when used on surfaces in areas such as locker rooms, shower and bath areas, exercise areas, dressing rooms, etc., at 0.5 oz./gallon.

Mold and Mildew Control-

At 0.5 oz./gallon, SYNFECT 256 will effectively inhibit the growth of mold and mildew and the odors caused by them when applied to hard, non-porous surfaces (as indicated in general instructions above). Allow to dry on surface and repeat when mildew growth returns.

*Virucidal Performance

At 0.5 oz. per gallon use-level, SYNFECT 256 was evaluated in the presence of 5% serum and 400 ppm hard water and found to be effective, against the following viruses: Influenza A/Brazil, Herpes Simplex Type 1, and Vaccinia on inanimate environmental surfaces.

Sanitizing - Non-food Contact Surfaces (such as floors, wall, tables, etc.). At 0.5 oz. per 5.5 gallon use-level, SYNFECT 256 is an effective sanitizer against *Staphylococcus aureus* and *Klebsiella pneumoniae* on hard porous and non-porous environmental surfaces. Treated surfaces must remain wet for 60 seconds.
