Directions for Use

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

ANTHRACNOSE - Golf Course Fairways: Apply **DACONIL 2787 Flowable Fungicide** in 30 to 40 gallons of water per acre. Begin applications when conditions favor disease development and repeat applications as long as these conditions persist. Under severe disease conditions use the highest rate and shortest interval corresponding with the application schedule selected from the table below:

<u>DISEASE</u>	<u>APPLICATION INTERVAL</u>	<u>APPLICATION RATE PER ACRE</u>
Anthracnose	7 - 14 Days	6 - 12 qts

Golf Course Tees and Greens and Ornamental Turfgrass: Apply **DACONIL 2787** in an adequate amount of water to provide complete coverage. This amount may vary from 2 to 10 gallons (approximately 8 to 38 liters) per 1,000 sq ft. See below for suggested rates and timing.

FUSARIUM (Gerlachia) PATCH For control of Fusarium patch only in areas where snow cover is intermittent or lacking during the winter, apply 8 to 14 fluid ounces of **DACONIL 2787 Flowable Fungicide** per 1,000 sq ft of turf area. Begin applications in late autumn and re-apply at 21 to 28 day intervals until conditions favorable for Fusarium patch no longer prevail.

NOTE: It is important to read and observe the precautionary statements and all other information appearing on the **DACONIL 2787 Flowable Fungicide** label. Use only as directed.
