) The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. A stamped copy is enclosed for your records. Submit one (5) copies of your final printed labeling prior to releasing the product for shipment.

You should delete the statement "**DO NOT** contaminate water by cleaning of equipment or disposal of wastes" under **Environmental Hazards**, as it is redundant with the second sentence under this section. You must also revise you labels as required by the WPS label acceptance letter dated 5/26/94.

Regarding EPA Reg. No. 50534-38, in addition to the aforementioned comments, under **Mixing Instructions**, put a period after "overnight", and revise the last statement to read, "Clean application equipment thoroughly after using by flushing with water in a safe place."

Read entire label before using this product.

General Information:

Ansar 170 Herbicide is useful for selective post-emergent weed control, particularly for grassy weeds. Its activity is enhanced by addition of a suitable surfactant to the spray solution. Is most effective on young, actively growing weeds at air temperatures above 70°F. Its phytotoxic properties are quickly inactivated on contact with the soil.

Mixing Instructions:

Ansar 170 Herbicide is completely water soluble. Fill the spray equipment tank about half full with water and add the required amount of herbicide and surfactant with agitation. Finish filling the tank with water and apply. After use, clean equipment thoroughly by flushing with water *in a safe place*. DO NOT Store spray solution in tank ~~for a prolonged period overnight~~. Although Ansar 170 Herbicide is only moderately corrosive, DO NOT use in galvanized or aluminum equipment.

Directions for Use:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. DO NOT apply this product through any type of irrigation equipment.

Cotton: Ansar 170 Herbicide is useful as a directed application in cotton for the post-emergent control of weeds and grasses such as johnsongrass, crabgrass, nutsedge, dallisgrass, cocklebur, ragweed, sandbur and puncture vine. It should be applied at the rate of 2-1/2 pints per acre. Add 6 pints of Ansar 170 Herbicide and 1 to 2 quarts of a suitable surfactant, cleared for application to growing crops, to 100 gallons of water and mix thoroughly. Apply spray solution at 40 gallons per treated acre. Weed control is most effective at temperatures above 70°F. For band application in 40 inch rows, apply 1 gallon of spray solution per inch of band width per acre to cotton. Direct the spray solution to the base of the cotton plant. Nozzles should be placed so as to avoid spraying the cotton foliage. If regrowth occurs, make a second application about 1 to 3 weeks after the first. Slight burning and a reddish discoloration of the cotton leaf may occasionally occur following the recommended treatment, but the cotton plant will develop normally and yield will not be affected. Apply only when cotton is 3 inches high to first bloom. DO NOT apply after first bloom. DO NOT feed treated foliage to livestock or graze treated areas.

Non-Crop: Ansar 170 Herbicide is useful for controlling of johnsongrass, nutsedge and certain other weeds on drainage ditchbanks, rights-of-way, storage yards and similar non-crop areas.

Mix Ansar 170 Herbicide at a rate of 3 to 6 pints, plus 1 to 2 quarts of a suitable surfactant in 100 gallons of water. Spray the unwanted vegetation thoroughly to just short of run-off. Any spray equipment that gives good coverage may be used. If regrowth occurs, reapply as required. DO NOT contaminate waters used for domestic purposes, or by animals, including wildlife and aquatic life, or water used for irrigation purposes.

Lawn And Ornamental Turf: Ansar 170 Herbicide is useful for control of dallisgrass, sandbur, crabgrass, bahiagrass, nutsedge, chickweed and wood sorrel with little or not injury to tolerant lawn grasses. On new lawns, DO NOT treat until after three mowings. Tolerant grasses may be temporarily discolored. Zoysia, bluegrasses, and Bermuda grasses are quite tolerant. DO NOT use on St. Augustinegrass, carpet grass, centipedegrass, or on *Dichondra*. Mow lawns 1 to 1-1/2 inches high before treatment. Mix 1 fluid ounce (2 tablespoons) of Ansar 170 Herbicide and 1/2 fluid ounce (1 tablespoon) of a suitable surfactant in 2-1/2 gallons of water and apply to an area of 1,000 square feet. Spray thoroughly to wet all undesirable plants. Repeat applications, 10 to 14 days apart, may be needed for good control. DO NOT apply with hose-end applicators. *DO NOT reseed until two weeks after last application. DO NOT water turf for at least 24 hours AFTER application.*

Storage and Disposal

DO NOT contaminate water, food or feed by storage or disposal. Open dumping is prohibited.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: DO NOT reuse empty container.
