 Your Applications & Letters Dated 5/12/94

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. A stamped copy is enclosed for your records. Submit five (5) copies of your final printed labeling prior to releasing the product for shipment.

Except for EPA Reg. No. 50534-106, you should delete the statement "DO NOT contaminate water by cleaning of equipment or disposal of wastes" under **Environmental Hazards**, as it is redundant with the second sentence under this section. You must also revise your labels as required by the WPS label acceptance letter dated 5/26/94, and 5/31/94 for EPA Reg. No. 50534-50.

Regarding EPA Reg. No. 50534-50, in addition to the aforementioned comments, under **Hazards to Humans and Domestic Animals**, revise "In case of contact..." to "If In Eyes...", and preface "Wash exposed skin..." with "If On Skin". Under **Mixing Instructions**, in the first sentence, delete the "s" from "Herbicides".

Under **Cotton**, and **Non-Crop**, the directions for use must be revised to reflect those application rates on your label stamped "ACCEPTED DEC 14 1983". Under **Cotton** revise to read, "Mix 3 quarts of Monex 3 Herbicide in 90 gallons of water..." Under **Non-Crop**, revise to read, "Mix 2-4 quarts of Monex 3 Herbicide in 100 gallons of water."

Regarding EPA Reg. No. 50534-54, in addition to the aforementioned comments, under **Storage and Disposal**, revise the second sentence of the container disposal instructions to read, "Triple rinse...sanitary landfill, or by incineration, or by other procedures, such as burning, if approved by state and local authorities. If burned, stay out of smoke."

Regarding EPA Reg. No. 50534-106, reinstate "Do not spray or allow drift onto vegetables, ornamentals or other desirable plants" under the **Non-Crop** section of your label.

MONEX 3 Herbicide is useful for selective post-emergent weed control, particularly for grassy weeds. It is a combination of herbicides and surfactant. IT IS UNNECESSARY TO ADD ANY OTHER SURFACTANT TO THE SPRAY SOLUTION. Best results are obtained on young, actively growing weeds at air temperatures above 70°F.

Mixing Instructions: Shake the MONEX 3 Herbicide container thoroughly before using. Fill the spray equipment reservoir with water and add the required amount of MONEX 3 Herbicide with agitation. Continue agitation during application. After use, clean equipment thoroughly by flushing with water in a safe place. DO NOT store spray solution in tank overnight.

Directions For Use:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

Cotton: MONEX 3 Herbicide is useful as a directed application in cotton for post-emergent control of weeds such as johnsongrass, nutsedge, dallisgrass, goosegrass, barnyardgrass, cocklebur, sandbur, puncture vine and morning glory. It should be applied at the rate of 2 quarts per acre. Mix 2 quarts of MONEX 3 Herbicide in 40 gallons of water and apply as a directed spray at 40 gallons per acre. Weed control is most effective at temperatures above 70°F. For band application in 40 inch rows, apply 1 gallon of spray solution per inch of band width per acre. Direct the spray solution to the base of the cotton plant. Nozzles should be placed so as to avoid spraying the cotton foliage. A second application may be required during humid growing conditions to control perennials such as johnsongrass and nutsedge. Apply the second application 1 to 3 weeks later. Slight burning and a reddish discoloration of the cotton leaf may occasionally occur following the recommended treatment, but the cotton plant will develop normally *and yield will not be affected.*

APPLY ONLY WHEN COTTON IS 6 INCHES HIGH TO FIRST BLOOM. DO NOT APPLY AFTER FIRST BLOOM. DO NOT FEED TREATED FOLIAGE TO LIVESTOCK OR GLAZE TREATED AREAS.

Non-Crop: MONEX 3 Herbicide is useful for control of johnsongrass, nutsedge, barnyardgrass, morning glory and other weeds on drainage ditch banks, rights-of-way, fence rows, storage yards and other non-crop areas.

Mix 5 quarts of MONEX 3 Herbicide in 100 gallons of water. Spray unwanted vegetation thoroughly to just short of run-off. Any spray equipment that gives good coverage may be used. If regrowth occurs, reapply as required.

DO NOT CONTAMINATE WATERS USED FOR DOMESTIC CONSUMPTION, OR BY ANIMALS, WILDLIFE OR AQUATIC LIFE, OR FOR IRRIGATION PURPOSES.

Storage and Disposal
