The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted subject to the comments reflected on the enclosed sheet. WHAT THIS ACCEPTANCE MEANS:

The following specific comments pertain to your WPS labeling submission concerning the product cited above:

The footwear requirement for "applicators and other handlers" in the "Personal Protective Equipment" section on your proposed labeling is missing or incorrect. Remove the incorrect requirement (if any) and add "Shoes plus socks." The exact location is shown in Sections A and B on Part 1 of the Product Worksheet in Supplement Three-A to PR Notice 93-7.

The footwear requirement for early entry in the Agricultural Use Requirements box on your proposed labeling is missing or incorrect. Remove the incorrect requirement (if any) and add "Shoes plus socks." The exact location is shown in Sections F and G on Part 2 of the Product Worksheet in Supplement Three-A to PR Notice 93-7.

Harmful if swallowed or absorbed through the skin. Avoid contact with eyes, skin or clothing. Avoid breathing dust or spray mist.

For exposures outdoors:

ANSAR 8100 Herbicide

Read entire label before using this product

General Information:

ANSAR 8100 Herbicide is useful for selective post-emergent weed control, particularly for grassy weeds. Its activity is enhanced by addition of a suitable surfactant to the spray solution. Is most effective on young, actively growing weeds at air temperatures above 70°F. Its phytotoxic properties are quickly inactivated on contact with the soil.

Mixing Instructions: ANSAR 8100 Herbicide is completely water soluble. Fill the spray equipment tank about half full with water and add the required amount of herbicide with agitation. Finish filling the tank with water and apply. DO NOT store spray solution in tank for a prolonged period overnight. and Clean application equipment thoroughly after using by flushing with water in a safe place. Although ANSAR 8100 Herbicide is only moderately corrosive, DO NOT use in galvanized or aluminum equipment.

Directions for Use

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the agency responsible for pesticide regulation.

AGRICULTURAL USE REQUIREMENTS Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

DO NOT enter or allow worker entry into treated areas during the restricted entry interval (REI) of 12 hours.

PPE required for early entry to treated areas that is permitted under the Worker Protection Standard and that involves contact with anything that has been treated, such as plants, soil, or water, is:

NON-AGRICULTURAL USE REQUIREMENTS

The requirements in this box apply to uses of this product that are NOT within the scope of the Worker Protection Standard for agricultural pesticides (40 CFR Part 170). The WPS applies when this product is used to produce agricultural plants on farms, forests, nurseries, or greenhouses.

Keep children and domestic animals off treated areas until this material has been washed into the soil.

DO NOT apply this product through any type of irrigation equipment.

Cotton: ANSAR 8100 Herbicide is useful as a directed spray application in cotton for the postemergent control of weeds and grasses including Johnsongrass, nutsedge, dallisgrass, cocklebur, crabgrass, ragweed, sandbur and puncture vine.

Mix 7.0 pounds of ANSAR 8100 Herbicide in 100 gallons of water and add 1 to 2 quarts suitable surfactant, cleared for application to growing crops. Weed control is most effective at temperatures above 70°F. For band application in 40 inch rows, apply 1 gallon of spray solution per inch of band width per acre of cotton.

Band Application: Direct the spray solution to the base of the cotton plant. Nozzles should be placed so as to avoid spraying the cotton foliage, but to give good coverage of the weeds and grasses. If regrowth occurs, make a second application about 1 to 3 weeks after the first. Slight burning and a reddish discoloration of the cotton leaf may occasionally occur following directed banc' application, but the cotton plant will develop normally and yield will not be affected.

Make band application only when cotton is 3 inches high to first bloom. DO NOT apply after first bloom.

NON-CROP: ANSAR 8100 Herbicide is useful as a spot applied herbicide for control of Johnsongrass, nutsedge, and certain other weeds on drainage ditch banks, rights-orway, fence rows, storage yards and similar non-crop areas.

Mix ANSAR 8100 Herbicide at a rate of 3 to 7 pounds, plus 1 to 2 quarts of a suitable surfactant in 100 gallons of water. Make spot applications on unwanted vegetation, spraying thoroughly, but to just short of run-off. Use spray equipment that gives good low volume coverage. If regrowth occurs, reapply as required.

DO NOT contaminate waters used for domestic consumption, or by animals, wildlife and aquatic life, or for irrigation purposes.

Lawn And Ornamental Turf: ANSAR 8100 Herbicide is useful for control of dallisgrass, sandbur, bahiagrass, nutsedge, crabgrass, chickweed and wood sorrel with little or no injury to tolerant lawn grasses. On new lawns, do not treat until after three mowings. Tolerant grasses may be temporarily discolored. Zoysia grasses, bluegrasses, and bermuda grasses are quite tolerant. DO NOT use on St. Augustinegrass, centipedegrass, grassescarpetgrass, or on Dichondra.

Mow lawns 1 to 1-1/2 inches high before treatment. Mix 1-1/2 ounces of ANSAR 8100 Herbicide in 2-1/2 gallons of water, containing 2 to 3 fluid ounces of a suitable surfactant. This will make enough spray material when used as a spot application to cover a total of 1000 sq. ft. Spot spray thoroughly to wet all undesirable plants. Repeat applications, 10 to 14 days apart, may be needed for good control.

DO NOT apply with hose-end applicators.

DO NOT water turf for at least 24 hours AFTER application. DO NOT reseed until two weeks after last application.

Storage and Disposal

DO NOT contaminate water, food or feed by storage or disposal. Open dumping is prohibited.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: DO NOT reuse empty container. Completely empty bag into application equipment by shaking and tapping sides and bottom to loosen clinging particles. Then dispose of empty bag in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.
