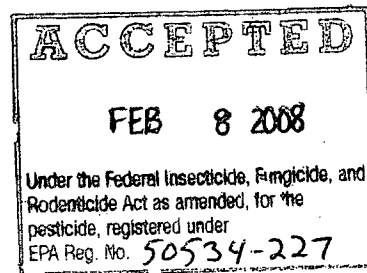

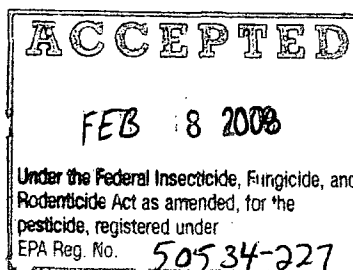

This product must not be used to formulate products for use as in-container preservatives.

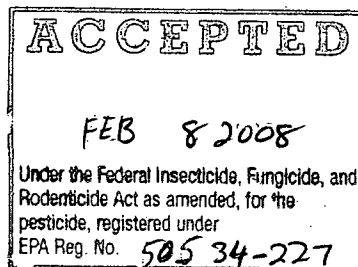
