Hydro-Klear 200 is used to control algae and bacteria in recirculating commercial and industrial water cooling towers. Proceed as use, systems houst be cleaned to remove algal growth, microbiological slime, and gitter deposits. An initial slug addition of 5.1 to 10.2 fluid cunces of Hydro-Klear 200 per 1600 gallons of water is recommended. Repeat initial dosage until control is evident,

Subsequent slug additions of 1.7 to 10.2 fluid ounces of Hydro-Klear 200 per 1000 gallons of water should be employed every 1 to 5 days, or as needed. The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem. Slug additions should be made in the sump of water cooling towers.

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.
