

Dear Velma,

Technology Sciences Group, Inc., on behalf of Specialty Chemical Manufacturing, is submitting the enclosed notification to update the storage and disposal statement, precautionary statement, and first aid statements, as well as to update the CSFs on file with EPA.

On October 26, 2010, Specialty Chemical Manufacturing submitted a notification per PR Notice 2007-4 to revise the storage and disposal statement and revise the precautionary and first aid statements on the product label. This notification was rejected by the Agency on December 3, 2010. Due to some confusion, Specialty Chemical Manufacturing never responded to the Antimicrobials Division's rejection.

On June 7, 2013, TSG, on behalf of Specialty Chemical Manufacturing, submitted a notification nearly identical to this one to update the label and CSFs. On July 8, 2013 the Agency rejected the notification as the proposed storage and disposal and warranty statements were unacceptable. This notification corrects the storage and disposal language per Agency revisions and removes the warranty statement. Per this notification, please see the attached redline product label incorporating those updates based on the Agency's comments.
