DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

To shampoo and kill fleas and ticks, follow these easy steps:

- 1) Thoroughly blend 1 oz. of Davis Pyrethrins with the required amount of your favorite grooming shampoo sufficient to make 1.0 gallon when mixed with water.
- 2) Wet animal thoroughly.
- 3) Apply a generous amount of shampoo mixture to the coat, massaging the lather well into the coat and skin.
- 4) Allow the lather to remain on animal for five minutes to permit pyrethrins to take full effect.
- 5) Rinse the animal thoroughly.

DISPOSAL

Do not reuse empty container. Wrap in newspapers and discard with trash.

HAZARDS TO HUMANS
