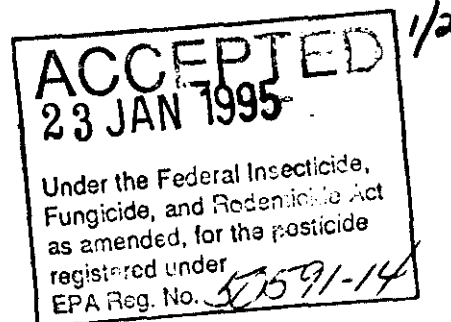

DOGS AND CATS

Cover animal's eyes with hands. With a firm stroke to get a proper spray mist; spray head, ears and chest until damp. With fingertips, rub into face around mouth, nose and eyes. Then spray neck, middle and hind quarters, finishing legs last. For best penetration of spray to the skin, direct spray against the natural lay of the hair. On long haired dogs rub your hand against the lay of the hair, spraying the ruffled hair directly behind the hand. Make sure spray thoroughly wets ticks. Repeat treatment as needed.

PUPPIES AND KITTENS

Treat same as dogs and cats except nursing puppies and kittens. Spray only along back or on your fingertips and rub in.

PET'S SLEEPING QUARTERS

Spray around baseboards, windows, door frames, wall cracks and local area of floors. If mosquitoes, gnats or flies are present, spray lightly in the air. Repeat as needed. The pet's bedding should be sprayed, making sure the area beneath the bedding is sprayed. After spray has dried, remove old bedding and replace with fresh bedding. Treat pets with one of our registered Flea & Tick control products before allowing them to enter treated area.

HORSES AND FOALS

Use full strength to control stable flies, horse flies, deer flies, face flies, gnats and mosquitoes. Apply to face, legs, flanks, top line and other body areas commonly attacked by these flies. Do not wet horses skin with excessive spray. After application, brush thoroughly to bring out sheen on coat. Repeat treatment as needed. Not for use on horses to be used as food.

Do not use this product in or on electrical equipment due to the possibility of shock hazard.

STORAGE AND DISPOSAL

STORAGE: Do not use or store near heat or open flame.

DISPOSAL: Do not reuse container. Wrap and put in trash.

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals

WARNING

HUMANS: Causes eye irritation. Do not get in eyes or on clothing. Harmful if swallowed or inhaled. Avoid breathing mist. Keep out of eyes. Avoid contamination of food. Wash hands with soap and water after using.

ANIMALS: Avoid treatment of nursing puppies and kittens under six weeks old. If treatment is necessary spray on tips of fingers and rub coat. Not for use on horses to be used as food.

ENVIRONMENTAL HAZARDS: This product is toxic to fish. Keep out of lakes, streams, ponds, tidal marshes and estuaries. Do not apply where runoff is likely to occur.

PHYSICAL OR CHEMICAL HAZARDS: Flammable. Keep away from heat and open flame.

STATEMENT OF PRACTICAL TREATMENT

IF IN EYES: Flush with plenty of water. Get medical attention.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists.

IF SWALLOWED: Drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol.

IF INHALED: Remove person to fresh air.
