

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

WARNING: Causes eye damage and skin irritation. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed. Avoid contamination of food.

STATEMENT OF PRACTICAL TREATMENT: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes call a physician. DIRECTIONS FOR USE  
GENERAL CLASSIFICATION

It is a violation of Federal law to use this product inconsistent with its labeling.

CARBO-30 is used in recirculating commercial and industrial water cooling systems must be cleaned to remove algal growth, other deposits. An initial slug addition of 1.5 CARBO-30 per 1000 gallons is recommended. Repeat initial dosage until control is evident. Subsequent slug additions of 0.5 CARBO-30 per 1000 gallons of every 1 to 5 days, or as needed. The frequency of relative amount of bleedoff and the severity of the mildew additions should be made in the sump of water cooling systems.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. STORAGE: Do not expose to extreme temperatures. Do not store more than five drums high. Drums should be opened in well-ventilated areas. Damaged drums should be placed in overpack drums and disposed of in a container closed when not in use.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law.
